Visa Instructions

- 1. Many participants of the 19th International Nondestructive Testing and Evaluation of Wood Symposium will need to obtain a Tourist Visa to attend the conference.
- 2. To obtain the specific instructions for your country (processing information and required documents), please see the website of the Brazilian Consulate in your country. The times required to process your visa application request and fees required vary, depending on country.

Scotland: Entrance allowed by presenting Civil Identity Card;

Sweden: Visa Exemption, for a period not exceeding ninety (90) days;

Hungary: Visa Exemption, for a period not exceeding ninety (90) days;

Canada: Visa Required;

Estonia: Visa Exemption, for a period not exceeding ninety (90) days;

Finland: Visa Exemption, for a period not exceeding ninety (90) days;

Chile: Visa Exemption, for a period not exceeding ninety (90) days. Entrance allowed by presenting Civil Identity Card;

Uruguay: Visa Exemption, for a period not exceeding ninety (90) days. Entrance allowed by presenting Civil Identity Card;

Australia: Visa Required;

Japan: Visa Required;

Germany: Visa Exemption, for a period not exceeding ninety (90) days;

Korea: Visa Exemption, for a period not exceeding ninety (90) days;

Colombia: Visa Exemption, for a period not exceeding ninety (90) days. Entrance allowed by presenting Civil Identity Card;

New Zealand: Visa Exemption, for a period not exceeding ninety (90) days;

Portugal: Visa Exemption, for a period not exceeding ninety (90) days;

France: Visa Exemption, for a period not exceeding ninety (90) days.
